GET THE HELP YOU NEED

We help veterans and their families get access to housing services.

TO BE ELIGIBLE YOU MUST:

- Be a veteran or member of a family in which the head of household or spouse of head of household is a veteran
- Have a very low income
- Be homeless or at imminent risk of homelessness

A case manager will assess your needs and situation to create a plan that will connect you to the right resources to help find or maintain housing.
